### **Reporting Entity**

The Transport Research & Educational Trust Board is a Charitable Trust incorporated under the Charitable Trust Act 1957. The Transport Research & Educational Trust Board has subsequently been registered under the Charities Act 2005.

#### **Basis of Preparation**

The entity has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

### Goods and Services Tax (GST)

The entity is not registered for GST. Therefore all amounts are stated inclusive of GST (if any).

#### **Income Tax**

Transport Research & Educational Trust Board is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

#### **Grants and Donation**

Grants and donation received are included in operating revenue. If particular conditions are not met, then the grant is recorded as a liability until the conditions are met.

#### **Changes in Accounting Policies**

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.
